

Taking place just a few months after the conclusion of SIDS-4, and a few months before COP16 of the Convention on Biological Diversity and COP29 of the United Nations Framework Convention on Climate Change, the first edition of the IWRA's Islands Water Congress will contribute to further shaping island's responses to the twin climate and nature crisis, highlighting the role of freshwater therein.







IWRA decided to do things a little bit differently for this Congress series

Every two years we will organise the event with a different host island (Faroe Islands for the 2024 first edition). The event focuses (also) on a concrete issue that is relevant for that island, but equally of interest to a global island audience. Within the wider Congress themes of Administration, Collaboration and Innovation, regulation will be the concrete issue to look out for in 2024.

The Congress will put forward information towards dealing with the issue mentioned above (regulation) by means of a variety of practical tools jointly agreed with the host island nation (Faroe Islands for the 2024 first edition). Such tools will be co-developed with Congress participants and organisations linked to the International Scientific Committee (ISC). After the event, they will be shared with host island policy makers and stakeholders and with wider global island audiences.

By organising a Congress every two years on different islands, IWRA will develop a body of learning that will boost freshwater opportunities and advance solutions to freshwater challenges. Where such body of learning is relevant to non-island audiences, good practices will be shared accordingly.

The First edition of the IWRA Islands Water Congress will focus on Administration, Collaboration and Innovation.

So join us for an extraordinary gathering where we unite to address freshwater issues within an island context!

For the purposes of Congress and its call for papers, by "ADMINISTRATION" we mean the different processes necessary to capture, process, deliver, use and dispose of freshwater on islands. By "COLLABORATION" we refer to the need to identify and bring together all stakeholders involved in the processes of the administration of freshwater on islands. And by "INNOVATION" we mean novel instruments, systems and technologies that improve freshwater administration.

The Congress seeks contributions reflecting the challenges experienced in islands from all geographic contexts to enable a broad discussion reflecting the diverse water challenges faced by islands.

PAPER PROPOSAL

We invite individual paper proposals that address one or more of the Congress themes listed above. Paper proposals should include an abstract of 300 words.

Please indicate if you wish your paper to be considered for publication. We plan to publish special issues from the Congress with Water International and the Island Studies Journal. The deadline for full paper submission for publication is listed below.

SPECIAL SESSISON PROPOSAL

The Congress also welcomes special session proposals, which should include abstracts for each paper up to a maximum of 1200 words. If your special session is organised in a different way (for example an experts roundtable), please enter a 500 words description of the special session indicating names and affiliations of speakers who will feature.

Impact is a key aspect of the Congress. Special sessions proposals are expected to include a brief statement on the desired or expected impact resulting from the special session or from implementation of ideas discussed at the session. In addition, special sessions organisers and/or participants may be invited to contribute to the practical tools jointly agreed with Faroe Islands key stakeholders. Such practical tools will be of specific application to the Faroese freshwater context, but also relevant to islands beyond the Faroe Islands more generally, as well as non-island nations and communities in some cases.

Creative PROPOSAL

We also invite proposals for innovative and creative sessions that address one or more of the Congress themes listed above. Sessions can include poetry readings, exhibitions, photography, performances of any kind and interactive activities.


